**COLORADO BOARD #4 dues for the 2024-2025 seasons are now due.
DEADLINE IS APRIL 15th, 2024!**

- It is time to register for the 2024-25 basketball season. **Remember this is a 2 part registration process (Colorado Board #4 and CHSAA Insurance/arbiter fee/background check).** Please register via a computer vs. your phone as better success on a computer
- If you have retired from officiating basketball or have moved out of state, please let us know and we will remove you from distribution.
- Last year we began the **2-part registration**: 1 – Colorado Board #4 registration **and** 2 – CHSAA insurance and arbiter access with this registration process continuing this season. This is in direct response to multi-sport officials paying insurance multiple times. Upon completion of the Colorado Board #4 registration, **follow the link to the CHSAA registration.** You will receive a confirmation email of successful registrations.

Step 1 – Colorado Board #4 Basketball Registration & Dues Fee (due APRIL 15th, 2024).

- **Postseason eligibility requirements include registering and payment along with a professional photo uploaded into arbiter, by this due date!**

The Basketball registration fee for 2024-25 is as follows:

<u>AFTER</u> APRIL 15, 2024	_____	\$105.00

To Pay Basketball(Colorado Board #4) Dues:

- Log into the arbiter (www.arbitersports.com), sign into sport account you are trying to register for 104526, click on the link in the middle of the page that says Click Here to Register, then click on the blue Register button. Then follow each screen through answering all the questions to the payment page (use the blue “Next” button in top right).
- Pay online with a credit card/debit card (**Colorado Board #4 has moved to online payment only**).
- Upon completing the Basketball registration, there is a success message on the screen which contains a link to the CHSAA registration. This same message with the link will be sent to you via email.

Step 2- To Pay CHSAA State Dues (due APRIL 15th, 2024):

Log into arbiter sports at www.arbitersports.com, then sign into the account 103372 Central Hub, then Click on the Registration Tab, then Click on the blue register button next to 2024 CHSAA Registration, then click on the sport, then follow each screen answering all questions through to the payment page (use the blue “Next” button in top right). Review personal and update addresses etc. as appropriate. Then enter your credit card/debit card.

- Insurance is \$7 and paid one time a year at the time of your first sport officiated
- Arbiter access is \$10 per sport
- Background check is \$10 due every 3 years, ARBITER WILL CHARGE YOU FOR A BACKGROUND CHECK IF YOU NEED IT. IF YOU DO NOT NEED IT, YOU WILL GIVE CONSENT AND THE SYSTEM WILL NOT CHARGE YOU!
